

RELEASE AND HOLD HARMLESS AGREEMENT - ALL WATERCRAFT

The undersigned is a customer of Seaside Waverunners LLC. He/She acknowledges that there may be risks inherent in the operation of equipment known as a Boat/Waverunner. The undersigned in consideration of the rental of the boat/waverunner to him/her acknowledges that he/she assumes the risk of any injury or death that may result from the use of the equipment and holds Seaside Waverunners LLC harmless from any claims for personal injuries or death. The undersigned further agrees to hold parties who may be injured as a result of the undersigned negligence. No operators under the age of 16 are permitted to rent Boats or Waverunners.

DAMAGE WAIVER

LESSEE STATES: I have rented the boat/waverunner and equipment from the lessor above and received it in good condition. I agree to pay for damage done to the boat/waverunner in accordance with the applicable Federal and State Laws and rules and regulations, and agree that I will be responsible for any fines or penalties assessed for any infraction of laws or rules committed by me while operation the boat/Waverunner. I assume FULL RESPONSIBILITY should the boat/waverunner covered by this lease become involved in an accident, which may result in damage or destruction of any property or injury to any person.

PRE BOARD CHECK LIST

- 4. Stay 50 yards off shoreline
- 5. Give other vessell (s) the right of way
- 6. Look before you turn
- 7. Wear protective clothing
- 8. Maintain a proper look out
- 9. Maintain a SAFE speed
- 10. Never operate a craft after consumption of drugs or alcohol
- 11. I have received and understand the instruction in safe boating covering the United States Coastguard Navigation Rules, Equipment requirements for class A vessels, and operation of personal watercraft.

- 13. No Tubing or Water Skiing
- 14. Overtime Fees will be charged if returned late.
- 15. Please return all Watercraft in same condition as you received it (See Damage Waiver above).
